

The following promotion is intended for participants in the United States only, and will be governed by United States laws. 92.5 XTU “WIN A DECK” Promotion Rules

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE ENTRANT’S CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the 92.5 XTU “WIN A DECK” promotion (“Promotion”), which is being conducted by /WXTU (“Station”). The Promotion begins on December 15, 2017 and ends on January 5, 2018 (“Promotion Dates”).
- b. To enter in the Promotion entrant may enter online beginning at 1:00pm ET December 15, 2017 and ending at 11:59pm ET on January 4, 2018 (“Entry Period”).
 - i. To enter online, visit www.925xtu.com/deck and follow the links and instructions to enter the Promotion and complete and submit the online entry form during the Entry Period. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Entry Period regardless if entrant has more than one email address or phone number. Multiple participants are not permitted to share the same email address or phone number, and only one email address or phone number may be used per entrant. P.O. Boxes are not permitted. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Promotion administrator.
- c. Thirty (30) Qualifying Prize winners and one (1) Grand Prize winner will be selected in the Promotion.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all legal U.S. residents who are 18 years of age or older at time of entry and who reside in the Delaware Valley area including the following counties in NJ: Burlington, Camden, Gloucester, Cumberland, Salem, Mercer and in DE: New Castle and in PA: Philadelphia, Delaware, Montgomery, Bucks, Lancaster, Berks, Chester, Lehigh, Northampton. Void everywhere else and where prohibited or restricted by law. Employees, officers, directors and agents of the Philadelphia Home Show, Great Railing, the Station, CBS Radio Inc., Entercom, each of their

respective parents, subsidiaries, and affiliates, the Station's advertising and promotion agencies, and participating sponsors or prize suppliers (collectively, the "Promotion Entities") and other radio stations in the Station's market, the members of their immediate families (spouses, parents, children, and siblings, regardless of where they reside) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects, and entrant agrees to waive any right to claim ambiguity in the Promotion or Official Rules, except where prohibited by law.

- b. Listeners are eligible to win a Station contest only once every 24 hours (1) day and a prize valued at \$2,500 or more, only once every six months. Only one (1) winner per household is permitted in any Station-conducted promotion.
- c. The winner(s) may be required to present valid government-issued photo identification and must provide winner's complete address, date of birth and phone number to claim a prize(s).
- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

3. PRIZES

- a. Up to thirty (30) Qualifying Prizes will be awarded in the Promotion. Each Qualifying Prize is two (2) general admission tickets to the Philadelphia Home Show on Saturday, January 13, 2018. The Approximate Retail Value ("ARV") of the Qualifying Prize is \$26.00. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). Tickets are valid only on the date(s) printed on the tickets, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Promotion Entities, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). The Station, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).

- b. One (1) Grand Prize will be awarded in the Promotion. The Grand Prize is a DIY (Do it yourself – the winner will need to put together the deck themselves) 10x10' VEKAdeck with vinyl railing and pressure treated frame deck kit from Great Railing. Kit includes decking; square vinyl railing; 4 x 4 posts; vinyl post skirts; PT 2 x 8 joists, double beams and posts; starter strips; finishing trim and plans. Kit does not include hardware or installation. The ARV of the Grand Prize is \$1,132.00. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize, including any requisite permits and zoning compliance. The prize is awarded as is. Free delivery of the Grand Prize to addresses within 50 miles of the Pennsylvania Convention Center will be provided. A winner outside of the 50 mile radius must arrange to claim the Grand Prize at Great Railing, located at 1086 North Black Horse Pike, Williamstown, NJ 08094.
- c. Total ARV of all prizes: \$1,912.00.
- d. No more than the stated number of prizes specified in these official rules will be awarded. Qualifying Prizes must be claimed at the will call booth at the Philadelphia Home Show at the Pennsylvania Convention Center, Exhibition Hall F, 12th & Arch Streets, Philadelphia, PA 19107 on January 13, 2018. Qualifying Prize winners will forfeit any Qualifying Prize not claimed by 6:00pm ET on January 13, 2018. The Grand Prize winner will forfeit the Grand Prize if not claimed within ninety (90) days of winning. In the event that the Station delivers the prize to the winner by mail or courier with the winner's consent, the winner assumes the risk of the prize's loss, damage or delay..
- e. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). The Prize(s) is provided as is. Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose, with the exception of any standard manufacturer's warranty that may apply. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.

- b. Thirty (30) potential Qualifying Prize winners will be selected on January 5, 2018 at approximately 10:00am ET by the Station in a random drawing of all eligible online entries received. Odds of winning the Qualifying Prize depend on the number of valid entries received.
- c. In order to be eligible to win the Grand Prize, Qualifying Prize winners must be present at the Grand Prize Giveaway event at 5:00pm ET on January 13, 2018 at the Philadelphia Home Show at the Pennsylvania Convention Center, Exhibition Hall F, 12th & Arch Streets, Philadelphia, PA 19107 and must have their valid photo ID to register when they arrive and check in with Station staff. All Qualifying Prize winners must be checked in between 5:00pm ET and 5:30pm ET. At approximately 5:30pm ET on January 13, 2018, each Qualifying Prize winner will be issued a number based on the order that they checked in and the number will be placed on the white ping pong ball. One at a time, each Qualifying Prize winner must drop the numbered ball into a tumbler. At approximately 6:00pm ET, the event announcer will reach into the tumbler and select one (1) ball and call out the number on the ball. When that number is announced, the Qualifying Prize winner with the corresponding number will be eliminated and will not win the Grand Prize. The Qualifying Prize winner who has the corresponding number with the last ball in the tumbler will win the Grand Prize.
- d. Odds of winning a Qualifying Prize depend on the number of online entries received. Odds of a Qualifying Prize winner winning the Grand Prize are approximately 1 in 30 but may be greater depending on how many Qualifying Prize winners are present at the Grand Prize event.
- e. Qualifying Prize winners do not need to listen to the Station or be present to win a Qualifying Prize. The Grand Prize winner does not need to listen to the Station to win the Grand Prize but must be present at the Grand Prize event to win the Grand Prize.
- f. Potential Qualifying Prize winners will be notified of winning by telephone promptly following the random drawing. Potential Grand Prize winner will be notified of winning onsite at the Grand Prize event. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Prize shall be available for pick up or delivery within two to three weeks following confirmation of eligibility and completion of all requisite releases and IRS forms. The Qualifying Prize winner(s) must execute and return any required affidavit of eligibility and/or liability/publicity by January 13, 2018 or prize(s) will be forfeited. The Grand Prize winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ninety (90) days of winning or prize(s) will be forfeited and an alternate winner will not be selected." If a winner has not reached the age of majority in his/her state of residence, the prize(s) will be awarded in the name of his/her parent or legal guardian. If a potential winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the required fully-executed affidavit of eligibility and/or liability/publicity release within the required time period,

or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize(s). The Promotion Entities are not responsible for any changes in an entrant or winner's email address, phone number, mailing address or other contact information.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner(s). The winner(s) may be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize(s) valued at \$600 or more or for any prizes awarded by the Station (or any other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent upon request will result in forfeiture of the prize(s). Such winnings of \$600 or more will be reported to the IRS.
- b. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) permission for the Station or its designees to interview the winner(s) (or guest(s), if applicable), to photograph, film and record each winner (or guest, if applicable), and to use in commerce, advertising and in any media, now or hereafter known, throughout the world, in perpetuity, his/her name, prize(s) won, hometown (city and state), biographic information, likeness, photograph, voice, audio or video recording and/or any statements made by him/her regarding the Station, the Promotion and/or its sponsor(s) for purposes of trade, publicity or promotion without notice or additional compensation, notification or permission, except where prohibited by law. Each winner (and guest, if applicable) agrees to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law.
- c. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) agreement to release, discharge, and hold harmless the Promotion Entities and their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns (collectively, the "Released Parties") from and against any and all claims or liability arising directly or indirectly from any prize(s) awarded and participation in the Promotion, including, but not limited to, personal injury, death or damage to or loss of property, which may occur in connection with, preparation for, travel to, or participation in the Promotion, or delivery, possession, acceptance and/or use or misuse of any prize or participation in any Promotion-related activity, including, but not limited to, any claims based on publicity rights, defamation, invasion of privacy and merchandise delivery.
- d. If for any reason this Promotion cannot be executed as planned, including but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Released Parties that corrupt or affect the security, administration, fairness, integrity

or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend and/or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).

- e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, unsuccessful, or late entries or notifications; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone or text message service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.
- f. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The use of any device to automate entry is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Promotion administrator's computer or telephone system is the official time keeping device for this Promotion. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.

- g. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the Promotion and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.
- h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. New York law governs the interpretation and construction of these Official Rules and all aspects related thereto.
- i.
